Terms and Conditions

Participation in the Promotion

1. By participating in the Promotion, the Participant agrees to these Terms and Conditions.
2. To participate in the Promotion, the Participant must be an Eligible Person who submits an Eligible Entry during the Promotion Period.
3. Eligible Persons may enter the Promotion once per day during the Promotion Period.
4. To enter the Promotion, the Eligible Person must during the Promotion Period:
 - (a) upload a photo of the Pelican Tree at the Centre to Instagram and tag @noosacivic and #keepnoosabeautiful ("**Eligible Entry**"), ensure that the Instagram account is public; and the photo taken is:
 - i. is not unlawful or promotes any unlawful activity;
 - ii. is not considered inappropriate, defamatory, abusive, discriminatory, offensive, obscene, threatening, misleading or hateful (as determined by the Promoter, in its absolute discretion);
 - iii. is not intended to harass another person or group of people;
 - iv. does not include personal information (including photographs) of another person or persons, unless with their express consent (or the express consent of their guardian, where applicable);
 - v. does not contain viruses or corrupted files;
 - vi. does not infringe the intellectual property rights of the Promoter Entities or the intellectual property rights of a third party; or
 - vii. does not contain advertising or promotional materials; and
 - (b) if the Eligible Person is under the age of 18 years, be consented to by a parent or guardian of the Eligible Person and any relevant consent form signed where applicable.

The Promotion

5. The Promotion will be conducted online on Instagram during the Promotion Period. The Promotion will end on expiration of the Promotion Period or earlier once all Gifts have been given away.

Eligibility

6. The Promotion is only open to Eligible Persons.
7. The Promoter reserves the right, at any time, to verify the eligibility of any Participant (including a Participant's identity, age and place of residence) and to disqualify any Participant who does not comply strictly with these Terms and Conditions or who tampers with the entry process. Incomplete, indecipherable or illegible entries will be deemed invalid. If requested by the Promoter, a Participant must provide the Promoter with evidence of eligibility. Failure by the Promoter to enforce any of its

rights at any stage does not constitute a waiver of those rights.

The Gift

8. For each Eligible Entry uploaded and tagged correctly, the Centre will donate \$1.00 to NICA (Noosa Integrated Catchment Association). There will be two thousand (2000) Gifts.
9. If a Prize Winner is under the age of 18 years, the parent or guardian of the Prize Winner who gave permission for entry into the Competition will be deemed to be a Prize Winner for the purposes of the Competition.
10. The Gifts are not transferable, refundable or exchangeable and cannot be taken as cash.
11. The first two thousand (2000) Eligible Entries will have \$1.00 donated by the Centre to NICA.
12. The Promoter may, but is not obliged to, publish the results of the Promotion. By participating in the Promotion, the Participant gives their consent for their personal details to be published in the manner prescribed in this clause if they are the recipient of a Gift. If the Promoter decides to publish the results of the Competition, then the Promoter will publish the results on the Centre's Facebook and Instagram pages.
13. The Gifts are subject to the conditions relating to the use of the Gift (including validity period) which can be obtained directly from the Gift provider and can be viewed at www.noosacivicshopping.com.au.

Other General Terms

14. All Promotion entries are the property of the Promoter.
15. Each Participant:
 - (a) presently assigns to the Promoter all Intellectual Property Rights in or for the Materials and all existing and future materials created (whether alone or jointly with the Promoter) by the Participant in relation to the Materials;
 - (b) warrants that the Participant has the right to make this assignment and that the Promoter's use of the Materials will not infringe any Intellectual Property Rights of any third party; and
 - (c) voluntarily, irrevocably and unconditionally consents to the Promoter, or persons authorised by the Promoter, doing or omitting to do, with respect to the Materials, any act which would otherwise infringe the Participant's Moral Rights in the Materials.
16. The Promoter Entities and/or Instagram shall not be liable (including, without limitation, in negligence) for:
 - (c) any loss or damage whatsoever that is suffered (including, but not limited to, indirect or consequential loss); or
 - (d) any personal injury suffered or sustained, during the course of participating in this Promotion or using the Gift, except for and to the extent that any liability cannot be excluded by law.
17. Each Participant indemnifies and keeps indemnified the Promoter Entities and/or Instagram against all claims,

losses, damages, costs and expenses suffered or incurred by the Promoter Entities or any third parties arising out of the breach of these Terms and Conditions by the Participant, the conduct of the Participant in the Promotion or the use of the Gift by the Participant.

18. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law and subject to any written directions from a regulatory authority (if any) to:
- (a) disqualify any Participant; and/or
 - (b) modify, suspend, terminate or cancel the Promotion as appropriate.
 - (c) The Competition is not sponsored, endorsed, administered by, or associated with, Instagram. The Participant agrees that Instagram will not be responsible for any claims, losses, damages, costs and expenses of any kind associated with this Competition and releases Instagram to the full extent permitted by law.
 - (d) Any information provided by the Participant in this Competition is being provided to the Promoter and not to Instagram.

Privacy

19. Under the *Privacy Act 1998* (Cth), the Promoter must notify Participants of certain matters when it collects personal information about them including how it plans to use or disclose it. If a Participant chooses to enter or take part in the Promotion, the Participant may be required to provide the Promoter with personal information about themselves such as the Participant's name, telephone number, email address and Instagram handle.
20. The Promoter will collect, use and disclose the personal information which the Participant has provided for the purpose of carrying out the Promotion (including as described in clause 12 in particular and in general for notification and promotion of Gifts).
21. By entering the Promotion, the Participant consents to the collection, use and disclosure of his or her personal information in the manner outlined in these Terms and Conditions.
22. If a Participant would prefer that the Promoter does not use or disclose the Participant's personal information in the way outlined in these Terms and Conditions and/or retain their personal information for the purposes described herein, the Participant should contact the Promoter on 07 5440 7900.
23. A Participant has the right to access, in most circumstances, personal information which the Promoter holds about the Participant. A Participant may contact the Promoter on 07 5440 7900 to ask for access to the Participant's personal information, or if the Participant has a complaint concerning a Participant's information privacy. The Promoter may deny the participant's request for access in some circumstances. If the Promoter does this, it will tell the Participant why.

24. The Promoter's Privacy Policy contains further information on its processes in relation to access to and correction of personal information, about how a Participant may complain about a breach of the Australian Privacy Principles and how the Promoter will deal with such a complaint. 25. If a Participant considers that any personal information that the Promoter holds about the Participant is inaccurate or if at any time the Participant's details change, the Participant may contact the Promoter on 07 5440 7900 and the Promoter will take reasonable steps to ensure that such personal information is corrected. The Promoter will take reasonable steps to keep personal information secure from misuse, interference, loss or unauthorised access, modification or disclosure.

Definitions

"Centre" means Noosa Civic Shopping Centre located at 28 Eenie Creek Road, Noosaville Qld 4566.

"Eligible Entry" means an entry which complies with the requirements of clause 4.

"Eligible Person" means an individual who:

- (a) is a resident of Queensland;
- (b) if under 18 years of age, has a parent or guardian's permission to participate in the Promotion;
- (c) is not a Non Eligible Person; and
- (d) submits an Eligible Entry.

"Gift" means two thousand (2000) \$1.00 donations to NICA – Noosa Integrated Catchment Association or any substitute Gift of a similar replacement type and value as determined by the Promoter.

"Intellectual Property Rights" means all intellectual property rights, including copyright and any right to keep confidential information confidential.

- (e) any spouse, child, de facto or any other person living at the same premises as any of the persons mentioned in paragraphs (a) – (d).

"Participant" means any person who participates in the Promotion.
